LOCTITE[®] AA 3081[™] is designed for bonding cannulae into hubs, syringes and lancets. LOCTITE[®] AA 3081[™] has excellent adhesion to glass, metal and certain thermoplastic substrates. The ability of this product to flouresce under black light facilitates inspection of bonded assemblies for adhesive. The low viscosity of this product makes it ideal for applications where wicking of the adhesive into pre-assembled parts is desired. Suitable for use in the assembly of **disposable medical devices**.

TYPICAL CURING PERFORMANCE

LOCTITE[®] AA 3081™ is recommended to be cured with a high intensity UV source, such as a medium pressure mercury arc lamp or an Electrodeless system, capable of generating an irradiance of 100 mW/cm² @ 365nm at the bondline. Cure rate and ultimate depth of cure depend on light intensity, spectral distribution of the light source, exposure time and light transmittance of the substrate through which the light must pass

Fixture Time

Fixture time is defined as the time to develop a shear strength of 0.1 N/mm² .

Effects of Sterilization

In general, products similiar in composition to LOCTITE[®] AA 3081[™] subjected to standard sterilization methods, such as EtO and Gamma Radiation (25 to 50 kiloGrays cumulative) show excellent bond strength retention. LOCTITE[®] AA 3081[™] maintains bond strength after 1 cycle of steam autoclave. It is recommended that customers test specific parts after subjecting them to the preferred sterilization method. Consult with Loctite[®] for a product recommendation if your device will see more than 3 sterilization cycles.

GENERAL INFORMATION

This product is not recommended for use in pure oxygen and/or oxygen rich systems and should not be selected as a sealant for chlorine or other strong oxidizing materials.

For safe handling information on this product, consult the Safety Data Sheet (SDS).

Directions for use:

- This product is light sensitive; exposure to daylight, UV light and artificial lighting should be kept to a minimum during storage and handling.
- 2. The product should be dispensed from applicators with black feedlines.
- For best performance bond surfaces should be clean and free from grease.



- Cure rate is dependent on lamp intensity, distance from light source, depth of cure needed or bondline gap and light transmittance of the substrate through which the radiation must pass.
- Recommended intensity for cure in bondline situation is 5 mW/cm² minimum (measured at the bondline) with an exposure time of 4-5 times the fixture time at the same intensity.
- For dry curing of exposed surfaces, higher intensity UV is required (100 mW/cm²).
- 7. Cooling should be provided for temperature sensitive substrates such as thermoplastics.
- 8. Plastic grades should be checked for risk of stress cracking when exposed to liquid adhesive.
- 9. Excess uncured adhesive can be wiped away with organic solvent (e.g. Acetone).
- Bonds should be allowed to cool before subjecting to any service loads.
